

Attachment No. 1. "Prohibited Goods" to the General Terms and Conditions of Droplo.com

Article 1. Prohibited Goods

The following goods cannot be part of the Offer:

1. Items originating from criminal activities
2. Money, securities, and other payment-related documents
3. Valuable items such as jewelry, artworks, antiques, numismatics, etc.
4. Items containing pornographic content
5. Symbols or products containing fascist or other totalitarian state symbols, or promoting such systems, or inciting hatred based on nationality, ethnicity, race, religion, or irreligion – except for goods with artistic, educational, collectors', or scientific value
6. Infringing on the personal rights of third parties
7. Music, films, software, and other goods infringing intellectual property rights
8. Non-original products (e.g., counterfeits, items violating industrial property rights)
9. Explosive materials and hazardous chemicals
10. Narcotics, psychotropic substances, intoxicants, cannabis seeds
11. Prescription drugs and other medicinal products, excluding medicinal and veterinary products
12. Alcoholic beverages
13. Tobacco products, e-cigarettes, e-liquid bases/flavors, e-liquids (including those without nicotine), spare containers and parts, tobacco heaters and parts, nicotine pouches
14. Live or dead animals (and their parts or derivative products) of species listed in Annexes A-D of Council Regulation (EC) No. 338/97 of 9 December 1996 on the protection of wild fauna and flora by regulating trade in such species
15. Shares in companies, stocks, bonds, and other securities, receivables, investment fund units, insurance policies and products, and all other financial instruments offered as forms of investment or capital placement, except for securities in material form with only collectors' value
16. Virtual currencies within the meaning of Article 2, paragraph 2, point 26 of the Anti-Money Laundering and Terrorist Financing Act (Journal of Laws 2021, No. 1132), including cryptocurrencies like Bitcoin, Litecoin, Dogecoin, etc., and related services and products
17. Software violating the manufacturer's license, test versions, freeware, shareware, abandonware
18. Software adapted to perform actions violating legal regulations or good customs
19. Websites and FTP server addresses (excluding domain names)
20. Access to torrent sites, accounts in free online services, and related services (e.g., likes, reviews, comments)
21. Access to erotic/pornographic websites and virtual currencies used in such services
22. Accounts in affiliate and loyalty programs, and services related to such programs
23. Databases (including personal data or email address lists)

24. Mail-order and direct sales catalogs used for ordering goods, except outdated catalogs with only collectors' value
25. Stock investment systems, number games, and betting systems, as well as services assisting participation in such games and making such bets, except official published books with an ISBN
26. Fishing tools and devices whose possession is restricted by law
27. Firearms and ammunition as defined in the Firearms and Ammunition Act
28. Substances with explosive, flammable, oxidizing, irritating, corrosive, allergenic, carcinogenic, mutagenic properties, or harmful to reproduction, posing a threat to human health, life, or property damage to logistics companies
29. Discount vouchers, coupons, or promissory notes offering future discounts or other benefits on purchases of goods outside the Droplo Platform
30. Gold in the form of bars, coins, or their copies and imitations, as well as silver in the form of bars or their copies and imitations
31. Prepaid payment cards (so-called prepaid cards)
32. Prepaid telephone cards
33. Counterfeit money still in circulation (counterfeits/imitations of Polish and foreign currency)
34. Collector's documents (copies of documents issued on demand)
35. Any kind of codes, passwords, tokens, keys, or accounts (collectively referred to as "Codes") that grant access to services allowing the viewing or listening of multimedia content on demand over the internet, including music, podcasts, and films (e.g., Netflix, HBO Max, Cda Premium, VOD.pl, Player.pl, Spotify, Tidal, Storytel), except for Codes offered by entities authorized to resell such services under individual contracts with the Company
36. Firecrackers and pyrotechnic materials of classes P2, F4, and T2
37. Live specimens of plants and animals recognized as posing a threat to the European Union, as listed in the catalog of invasive alien species established by Regulation (EU) No. 1143/2014 of the European Parliament and Council of 22 October 2014 on preventive and corrective actions regarding the introduction and spread of invasive alien species
38. Any form of permanent or temporary access to or use of an account or other collection of resources (similar to accounts) in any website, program, or app that enables handling and playing computer games, console games, or mobile games, or includes other functionalities and services related to those games, such as purchasing, installation, storage, review, and tracking statistics (e.g., Steam, Epic Games Store, GOG, Ubisoft Connect, Origin, PlayStation Network, Xbox Live). This prohibition does not apply to the sale of accounts or other resources in any website, program, or app that only allows access to games where use is free for all at all times
39. Medical devices, systems, and treatment kits within the meaning of the Medical Devices Act of April 7, 2022, violating the prohibitions specified in Article 16 of this Act, including medical devices for in vitro diagnostics, intended for self-use other than self-control devices, sample containers, or general-purpose laboratory products
40. Slot machines (gaming machines) as defined by the Gambling Act of November 19, 2009

41. Software under an OEM license
42. Used goods that should not be resold for safety reasons
43. Items containing terrorist content under the European Parliament and Council Regulation (EU) 2021/784 of April 29, 2021, on preventing the dissemination of terrorist content online
